
**COUNT I - RAPE OF A CHILD IN THE FIRST DEGREE, RCW 9A.44.073 - CLASS A FELONY:**

In that the defendant, JUAN VILLANUEVA-SANTOS, in the State of Washington, on or between January 1, 2010 and December 31, 2014, in a separate and distinct incident than alleged in Count I, did have sexual intercourse with E.T.V., who was less than 12 years old, and was not married to the defendant, and the defendant was at least twenty-four months older than E.T.V.
